




Southwest Florida



Regular Programs at FCSO (& equipment used)

- Drop-in library hour for two different units: signing residents up for new library cards, getting old library accounts into good standing/clearing old fines, bringing a selection of paperback library books for residents to check out, filling requests for specific books. All material is brought in a week in advance for security to search.
- We are permitted one rolling book cart, a laptop that is not connected to the internet, and a barcode scanner.
- "Read to the Children"-- recorded storytime program connecting caregivers & kids, planned around holidays (in the past: winter celebrations, Father's Day, Halloween)
- Pop-up at the Re-entry Center once per month, connecting with recently released folks or currently incarcerated residents who are off-site for educational programs or jobs






• Downloading the Securus Mobile app and clicking "Fund Securus Debit" to quickly add money without having to create or log into an account.






